- to determine share buy back fund amount as TRY 250,000,000 maximum, subject to cover it from Company internal sources,
- to determine the maximum number of shares that may be subject to buy-back will be in number of shares 40,000,000 (nominal TRY 40,000,000),
- to present the share buyback program and the buyback to be made within the scope of the program to the information of the shareholders at the first General Assembly Meeting,
- to authorize General Directorate for the transactions via Halk Yatırım Menkul Değerler A.Ş.
