According to the Communiqué on Principles Regarding Financial Reporting in Capital Markets (II-14.1) (Communiqué) Article 12/A, paragraph 4, it is essential that our Company, which is a subsidiary of our Parent Company Türkiye Halk Bankası A.Ş., shall submit its financial reports at the same time as our Parent Company or before, provided that it remains within the periods specified in the Communiqué.

The Board Decision dated 25.01.2024 and numbered 6/137, which includes the issues regarding granting additional time to the public for the announcement of their financial reports to companies that will apply inflation accounting within the scope of TAS 29 Financial Reporting Standards in High Inflation Economies, was published in the Capital Markets Board (CMB) Bulletin dated 25.01.2024 and numbered 2024/6, and the Additional Announcement regarding the Board Decision in question was published in the CMB Bulletin dated 23.01.2025 and numbered 2025/4. In this context, our Company has been granted an additional period for the announcement of the financial statements and independent audit report for the accounting period ending on June 30, 2025.

In this context, our Company's financial reports will be announced after our Parent Company Türkiye Halk Bankası A.Ş., provided that they remain within the additional period specified in the Bulletin.

The unconsolidated and consolidated financial statements of our Parent Company Türkiye Halk Bankası A.Ş. dated June 30, 2025 were prepared in accordance with the Banking Regulation and Supervision Agency (BRSA) legislation and without applying inflation accounting, in accordance with the relevant BRSA regulations.

The unconsolidated and consolidated financial statements and independent audit reports of our parent company, Türkiye Halk Bankası A.Ş., for the accounting period ending on June 30, 2025, which are not subject to inflation accounting and have undergone independent audit, were published on the Public Disclosure Platform and Türkiye Halk Bankası A.Ş. website on August 8, 2025 (<https://www.halkbank.com.tr/tr/yatirimci-iliskileri/finansal-bilgiler/finansal-bilgiler/finansal-tablolar-ve-bagimsiz-denetim-raporlari.html>)

It is expected that there will be a difference due to inflation accounting between the financial data of our Company, which are not subject to inflation adjustment and not subject to independent audit, and the financial data of our Company, which are included in the unconsolidated and consolidated audit reports of Türkiye Halk Bankası A.Ş. for the accounting period ending on 30.06.2025, and which are 59,513,838 thousand TL Total Assets, 40,881,703 thousand TL Total Equity, 26,054,630 thousand TL Total Fixed Assets, 95,255 thousand TL Interest Income, 4,375,489 thousand TL Current Period Profit/Loss,

3,191,985 thousand TL Previous Period Profit/Loss amounts and the financial data of our Company, which will be disclosed and subject to inflation accounting in accordance with TAS 29 and will be included in the independent audit report.

Our Company's limited audited financial statements, subject to inflation accounting for the accounting period ending on June 30, 2025, will be published on the Public Disclosure Platform and our Company's website (<https://www.halkgyo.com.tr/>) within the period specified in the legislation.

This statement has been made in accordance with the Decision No. 6/137 of the Capital Markets Board decision-making body dated 25.01.2024 and the additional announcement made in this context with the Decision No. 4/156 dated 23.01.2025, and we hereby declare that the responsibility arising from the information in the announcement is accepted.
