Additional Explanations

The share buyback program initiated by our company's Board of Directors' decision dated February 7, 2023, has ended due to reaching the maximum time limit stipulated in the Communiqué No. II-22.1 on Repurchased Shares, in accordance with the first paragraph of Article 7 of the Communiqué.

A total of 4,934,528 shares were repurchased under the buyback program at an average price of 4.06 TL; the total cost of the repurchased shares was 20,010,513 TL. The ratio of repurchased shares to the company's capital is 0.13%.

Our company holds 87,300,234 shares. (Ratio to company capital: 2.27%)
